The Bureau requests that Bill No. 151-37 (COR) be granted a waiver pursuant to Public Law 12-229, as amended for the following reason(s):

Bill No. 151-37 (COR) is an act to add a new Chapter 54C to Division 2, Title 10, Guam Code Annotated, relative to prohibiting the production and use of Nuclear Energy on Guam. The intent of *I Liheslaturan Guåhan* is to prohibit nuclear derived energy in the island of Guam.

It should be noted that the Bureau had sought input on the proposed Bill No. 151-37 (COR) from Guam Environmental Protection Agency on 7/24/2023 and 7/25/2023 and have not received any official comments as of the date of this fiscal note waiver. However, the bill is determined to be administrative in nature and poses no fiscal impact upon any of the funds of the Government of Guam.
