The Bureau requests that Bill No. 212-37 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 212-37 (LS) is an act to allow the transfer of a 707 square meter portion of Lot No. 5173-NEW-3 from the Chamorro Land Trust Commission to the Office of the Mayor of Tamuning.

Pursuant to the CLTC Resolution No. 2018-01 (as approved by the CLTC), the proposed legislation memorializes the transfer of Lot No. 5173-NEW-3 to the Tamuning Mayor's Office under the Guam Code Annotated (GCA). Additionally, this property is exempt from appraisal. Thus, the proposed legislation is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
