The Bureau requests that Bill No. 222-37 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 222-37 (COR) is an act to reserve Lot No. 2417-1-R7, formerly the Department of Public Health and Social Services' (DPHSS) Central Headquarters in Mangilao, to be used immediately by DPHSS as its 1) central community health center; 2) administrative office; and 3) any other related purpose as approved by the Governor of Guam. The bill also includes a provision exempting the proposed reservation of land for DPHSS from land appraisal requirements.

This bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
