The Bureau requests that Bill No. 282-37 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 282-37 (LS) is an act to add amend § 8102(v), § 8102(bb), and § 8104(b) of Article 1, Chapter 8, Title 5A, Guam Administrative Rules and Regulations, relative to removing the Praxis Core Mathematics requirement from the Guam Educator Certification Requirement.

The intent of the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam. However, there may be a positive impact to the Guam Commission for Educator Certification's Certification Fee Collection Revenue Account.
