The Bureau requests that Bill No. 295-37 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 295-37 (COR) is an Act amend §8104(a)(5)(A) and §8104(a)(5)(B), to renumber §8104(a)(5)(C), all of Chapter 8, Title 5, Guam Code Annotated; relative to modernizing public hearing notice requirements by authorizing the posting of public notices in locally licensed electronic newspapers and websites.

The proposed legislation establishes and defines the term of "eligible media platform" and expands the eligibility of "newspaper of general circulation" to include electronic publications.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
