The Bureau requests that Bill No. 319-37 (LS) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 319-37 (LS) is an act to repeal and re-enact §1203.1 of Article 2, Chapter 1, Title 12, Guam Code Annotated, relative to providing authority to the Antonio B. Won Pat International Airport Authority Guam to promulgate rules and regulations for the solicitation, selection, and award of concession agreements pursuant to the Administrative Adjudication Law or by enactment into law, and for contracts for the use of airport facilities and properties.

According to comments received from the Executive Manager of the Antonio B. Won Pat International Airport Authority Guam, the cost to implement this Bill is nominal as it pertains to promulgating rules and regulations in line with the Administrative Adjudication Law, especially in comparison to the potential benefits in return such as the airport being able to solicit, select, and award concession agreements. The Executive Manager stated that such agreements are critical in increasing and diversifying the airport's non-aeronautical revenues and improving its overall financial health.

The Bureau has determined that the Bill is administrative in nature and poses no additional fiscal impact upon any funds of the Government of Guam.
