The Bureau requests that Bill No. 356-37 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 356-37 (COR) is an act to *amend* the Guam Board of Allied Health Examiners administrative rules and regulations relative to including licensed professional counselors as clinical supervisors. The amendment contained in the proposed legislation adds the provision that a licensed professional counselor qualifies as a Clinical Supervisor.

As such, this bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
