The Bureau requests that Bill No. 376-37 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 376-37 (COR) is an Act to amend Public Law 37-135 to require autonomous agencies to pay Cost of Living Allowances (COLA) to its qualifying retirees.

The amendments listed in the proposed legislation mirror the same language of the administrative statutes relative to COLA payments contained in Chapter 11, Section 5, P.L. 37-125.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
