Bill No. 86-37 (COR) is an act to *amend* § 3222 of Article 2, Chapter 3, Title 10, Guam Code Annotated; and to *add* a new Chapter 37 to Title 7, Guam Code Annotated, relative to allowing individuals to change the legal sex designation on their birth certificates.
