The Bureau requests that Bill No. 97-37 (COR) be granted a waiver pursuant to Public Law 12-229, as amended for the following reason(s):

Bill No. 97-37 (COR) is an act to transfer Lot No. 106, Municipality of *Inalåhan*, formerly known as the *Inalåhan* Baptist Church to the Guam Preservation Trust.

The intent is to grant jurisdictional authority of the *Inalåhan* Baptist Church to the Guam Preservation Trust for the purpose of the stabilization and restoration of the *Inalåhan* Baptist Church. According to the Department of Land Management, the proposed legislation will not have any fiscal impact on the Department.

The Bill is administrative in nature and poses no additional fiscal impact upon any of the funds of Government of Guam.
