The Bureau requests that Bill No. 99-37 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 99-37 (COR) is an act to *amend* Section 29101 and Section 29103 of Chapter 29 of Title 10 of the Guam Code Annotated relative to swimming pools. The amendments contained in the proposed legislation are relative to the definitions of public and private swimming pools.
