The Bureau requests that Bill No. 45-37 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill 45-37 (COR) is an Act to amend §5230 of Chapter 5, Title 5, Guam Code Annotated, relative to clarifying the process for the determination of responsibility of bidders and offerors in procurement.

Per the legislative findings and intent, the proposed legislation intends to clarify standards and processes in making a determination of responsibility by providing for specialty requirements with the assistance of experts, as is necessary for successful completion of a contract, and will be applicable to all bidders and offerors.

As such, the Bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
