Bill No. 1-37 (COR) - AN ACT TO AMEND § 24105 OF CHAPTER 24, TITLE 11 GUAM CODE ANNOTATED RELATIVE TO EXCLUDING THE VALUE ADDED TO BUILDINGS FROM THE INSTALLATION OF PHOTOVOLTAIC SOLAR PANELS AND ROOF TILES FOR PURPOSES OF LEVYING REAL ESTATE TAXES.

Bill No. 3-37 (COR) - AN ACT TO AMEND SECTION 2 OF PUBLIC LAW 34-116 §26202 OF CHAPTER 26, TITLE 11, GUAM CODE ANNOTATED RELATIVE TO REDUCING THE BUSINESS PRIVILEGE TAX FROM FIVE PERCENT (5%) TO FOUR PERCENT (4%). ALL LIMITED EXEMPTIONS ON THE BUSINESS PRIVILEGE TAX IN §26203.2 OF CHAPTER 26 TITLE 11, GUAM CODE ANNOTATED REMAIN IN EFFECT AND ARE NOT CHANGED BY THIS ACT.

Bill No. 4-37 (COR) - AN ACT TO TEMPORARILY SUSPEND THE BUSINESS PRIVILEGE TAX ON FOOD AND MEDICINE, FOR TWELVE (12) CONSECUTIVE MONTHS.

Pursuant to 2 GCA §§ 9102 and 9103, each bill is required to be accompanied by a fiscal note or wavier thereof. Therefore, I respectfully request the preparation of a fiscal note or wavier for the bills referenced above.
