Håfa Adai Madam Speaker,

Bill No. 142-37 (COR) increases the generating capacity limit for Guam Power Authority ("GPA") non-residential customers utilizing solar energy technology from one hundred (100) to five hundred (500) kilowatts. While Bill No. 142-37 intends to promote the use of renewable energy and empower businesses to maximize solar technology, I cannot dismiss the testimony provided by our local utility agencies, the Guam Power Authority and the Public Utilities Commission ("PUC"), expressing serious concern about the negative impacts of this legislation.

GPA offered testimony that with this bill, 1,300 current Net Energy Metering ("NEM") program customers, specifically businesses, will be eligible for increases in generating capacity. GPA further noted that if twenty-five (25) percent of those customers increase their production in excess of (100) kilowatts, then this would result in an additional \$12M in revenue loss for GPA. Currently, NEM program customers do not contribute to operating costs of approximately \$5M annually, which are subsidized by non-NEM customers. GPA stated the additional loss of \$12 million in annual revenue as a result of the enactment of this bill would require GPA to file for rate increases to cover operating costs, which would be shifted to non-NEM customers, including low income, fixed income, and at-risk customers. Further, the PUC emphasized that net metering is not a solution to address load capacity issues facing GPA, as it has potential to overload circuits and

create instability impacting stable grid operation leading to more outages. The PUC echoed GPA's concerns about the negative financial impacts of the bill on non-NEM ratepayers.

My Administration has extended the Energy Credit Program (ECP) on five separate occasions to residential, master-metered, and commercial ratepayers. Though the program has provided substantial assistance to the community, it is also costly—to date the ECP has cost our government over \$110M. Based on the testimony of our utility agencies, the agencies anticipate that enactment of Bill No. 142-37 will negatively impact residential ratepayers. I am concerned that the average ratepayer, especially those currently struggling financially, will be crippled by rate increases, especially when the Energy Credit Program eventually comes to an end.

For these reasons, Bill No. 142-37 (COR) will lapse into law without my signature, as *Public Law No. 37-71*.

AN ACT TO AMEND §§ 8502(c)(2)(B) AND 8505(b)(3) OF ARTICLE 5, CHAPTER 8, TITLE 12, GUAM CODE ANNOTATED, RELATIVE TO NET METERING.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 and declares that during the recovery after Typhoon Mawar it has shown that, despite
- 4 improvements, Guam still relies heavily on traditional power-generation systems.

1	Nearly twenty (20) years ago, I Liheslatura recognized that photovoltaic, solar						
2	technology and other alternative energy-generation systems could help expand and						
3	safeguard the island's electric supply by the enactment of Public Law 27-132.						
4	I Liheslatura finds that the one hundred (100) kilowatt generating capacity						
5	limit for Guam Power Authority non-residential class customers was set over						
6	thirteen (13) years ago by the enactment of Public Law 30-141.						
7	I Liheslatura further finds that, since then, technology for renewable energy						
8	generation and storage has advanced significantly and will only continue to improve.						
9	I Liheslatura further finds that increasing the limit for non-residential class						
10	customers to five hundred (500) kilowatts would create an opportunity for entities						
11	that provide critical services to our island community to be less reliant on fossil fuels						
12	and continue operations during a power outage and or fuel shortages.						
13	I Liheslatura further finds that increasing the ability of businesses to						
14	maximize the use of solar energy technology aligns with the mandates of Public Law						
15	35-46, which requires the Guam Power Authority (GPA) to "establish a preliminary						
16	renewables portfolio standard goal of one hundred percent (100%) of its net						
17	electricity sales by December 31, 2045."						
18	Therefore, it is the intent of I Liheslaturan Guåhan to promote the use of						
19	renewable energy sources and permit businesses to maximize the use of solar energy						
20	technology in a manner that provides environmental and economic benefits.						
21	Section 2. § 8502(c)(2)(B) of Article 5, Chapter 8, Title 12, Guam Code						
22	Annotated, is hereby amended to read as follows:						
23	"(2) has a generating capacity limited to the following, provided,
