**NOTE ACTING SPEAKER MUÑA BARNES PRESIDES**

**ACTING SPEAKER MUÑA BARNES:** *HÅFA ADAI YAN MANANA SI YU'OS I MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN* IS CALLED TO ORDER COLLEAGUES AT THE REQUEST OF *I MAGA'HÅGAN GUÅHAN* TO CALL US INTO SPECIAL SESSION THIS MORNING OUR COLLEAGUES HAVE RECEIVED A COPY OF THE BILL SO AT THIS TIME I AM GOING TO CALL FOR FOR A RECESS TILL 1:30 SO THAT OUR COLLEAGUES CAN TAKE A LOOK WE WILL BE IN RECESS UNTIL 1:30 THIS AFTERNOON THANK YOU.

**ACTING SPEAKER MUÑA BARNES:** GOOD AFTERNOON COLLEAGUES MANY OF GOD'S BLESSINGS TO ALL OF US HERE IN THIS LEGISLATIVE HALL THE SEVENTH SPECIAL SESSION *I MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN* IS CALLED TO ORDER AT THIS TIME MAJORITY LEADER SENATOR AMANDA SHELTON YOU ARE RECOGNIZED AT THIS TIME.

**SENATOR SHELTON:** *SI YU'OS MA'ÅSE'* NOTWITHSTANDING THE HOUSE RULES I MOVE TO ADOPT TODAY'S SEVENTH SPECIAL SESSION AGENDA MARCH 12, 2024.

**SENATOR BLAS:** OBJECTION.

**SENATOR BLAS:** MOVE TO ADJOURN SUBJECT TO THE CALL OF THE SPEAKER.

**ACTING SPEAKER MUÑA BARNES:** THERE HAS BEEN A MOTION TO ADJOURN THIS CALL FOR THE SPECIAL SEVENTH SPECIAL SESSION.

**SENATOR SHELTON:** OBJECTION.

**ACTING SPEAKER MUÑA BARNES:** THERE IS NO AGENDA AT THIS TIME.

**SENATOR SHELTON:** NOTWITHSTANDING THE RULES MADAM SPEAKER.

**SENATOR BLAS:** THERE'S NO AGENDA YOU CAN'T NOTWITHSTANDING.

**ACTING SPEAKER MUÑA BARNES:** I WILL TAKE A MOMENT'S RECESS TO CONSULT WITH LEGAL COUNSEL.
