NOTE SPEAKER TERLAJE PRESIDES

SPEAKER TERLAJE: *I MINA'TRENTAI SIETTE NA LIHESLATURAN GUÅHAN* IS HEREBY CALLED TO SESSION PURSUANT TO THE GOVERNOR'S CALL TO A THIRD SPECIAL SESSION FOR MONDAY MARCH 20, 2023 AT 2:30 P.M. ACTING SENATOR TAITAGUE.

SENATOR TAITAGUE: POINT OF INFORMATION MADAM SPEAKER MADAM SPEAKER I REALIZE WE'RE GOING INTO THE THIRD CALL AGAIN FOR A SPECIAL SESSION TO YOU KNOW STOP US FROM ACTUALLY ADDRESSING THE TRUE NEEDS OF OUR OUR COMMUNITY AND THAT'S OUR CHILDREN WHO ARE IN WHO GO TO SCHOOL IN PLACES THAT ARE SO UNSAFE FOR THEM BUT ACTUALLY MADAM SPEAKER WHAT I'M BRINGING TO THE BODY'S ATTENTION IS WE RECEIVED THIS LETTER FOR THE THIRD SPECIAL SESSION HOWEVER I DIDN'T SEE AN ATTACHMENT I DIDN'T SEE IN THIS LETTER EVEN A BILL NUMBER AT ALL IT JUST SAID SEE ATTACHMENT AND MADAM SPEAKER I DON'T HAVE AN ATTACHMENT HERE SO I DON'T KNOW WHAT WE'RE GOING INTO THIRD SPECIAL SESSION FOR WITH NO ATTACHMENT NO MENTION OF ANY BILL THAT WE'RE SUPPOSED TO ADDRESS.

SPEAKER TERLAJE: THANK YOU SENATOR ASSISTANT MAJORITY LEADER SENATOR SAN AGUSTIN YOU ARE REST YOU ARE RECOGNIZED UNDER THE THIRD SPECIAL SESSION.

SENATOR SAN AGUSTIN: MADAM.

SENATOR FISHER: POINT OF INFORMATION.

SPEAKER TERLAJE: PLEASE STATE YOUR POINT OF INFORMATION SENATOR FISHER.

SENATOR FISHER: MADAM SPEAKER HAS A BILL AS ATTACHED OR HAS A BILL BEEN ATTACHED TO THIS THIRD CALL IF SO CAN I HAVE A COPY OF IT.

SENATOR TAITAGUE: MAKE A MOTION TO END THERE IS NO ATTACHMENT.

SENATOR FISHER: AND MADAM SPEAKER IF I COULD BE HEARD FOR THE PURPOSE OF MAKING A MOTION.

SENATOR TAITAGUE: JUST TO END.

SPEAKER TERLAJE: GIVE ME ONE SECOND I WANT TO CLARIFY THERE IS NO ATTACHMENT.

SENATOR TAITAGUE: THERE IS NO ATTACHMENT.

SENATOR FISHER: OKAY THEN MADAM SPEAKER I RISE FOR THE PURPOSE OF MAKING A MOTION TO I GUESS.

SPEAKER TERLAJE: WAIT WAIT JUST A SECOND SORRY.

SENATOR FISHER: WOULD IT BE OKAY.

SPEAKER TERLAJE: OKAY THERE'S NO ATTACHMENT ACCORDING TO THE TRANSMITTAL TO MY OFFICE AND WE ARE DID YOU HAVE A PRIORITY MOTION.

SENATOR FISHER: I BELIEVE SO LIKE SENATOR BARNETT I'M NEW TO THIS BUT THIS MOTION IS PURSUANT TO SECTION 780 OF MASON'S MANUAL SECTION 14 THE CALL IN THIS SPECIAL SESSION IS OVERLY BROAD AND IS INVALID AND THAT AGAIN IS SECTION 780 SUBPARAGRAPH 14 OF MASON'S MANUAL AND AND THAT OF COURSE

THE MOTION TO ADJOURN IS BASED ON THE FAILURE OF SPECIFICITY AND THE FAILURE TO ADD AN ATTACHMENT THANK YOU.

SPEAKER TERLAJE: THERE IS A MOTION TO ADJOURN A SPECIAL SESSION THE THIRD SPECIAL SESSION CALLED BY THE GOVERNOR IS THERE ANY OBJECTION.

SENATOR PARKINSON: OBJECTION.

SPEAKER TERLAJE: THERE'S BEEN AN OBJECTION.

SENATOR SAN AGUSTIN: MA'AM NO MADAM SPEAKER.

SPEAKER TERLAJE: SENATOR SAN AGUSTIN YOU ARE RECOGNIZED ON.

SENATOR SAN AGUSTIN: WE HAVEN'T EVEN STARTED HOW YOU ADJOURN WHEN YOU HAVE YOU HAVE TO START IT FIRST AND I HAVE THE THE STEPS TO START CAN WE AT LEAST START IT AND THEN YOU CAN WHATEVER THE BODY DECIDES AT THE END YOU CAN ADJOURN.

SPEAKER TERLAJE: WELL I HAVE CALLED US INTO ORDER AND SO THE MOTION TO ADJOURN IS IS PROPER AT THIS POINT IT'S IT'S PROPER AT ANY POINT YOU'RE RIGHT BUT IT'S ALSO PROPER AT THIS POINT SO THERE IS A MOTION THERE'S BEEN AN OBJECTION THE MOTION IS TO ADJOURN THAT GOVERNOR'S CALL TO A THIRD SPECIAL SESSION IS THERE ANY OBJECTION I MEAN SORRY ALL IN FAVOR OF THE MOTION TO ADJOURN PLEASE RAISE YOUR HAND FIVE SIX SEVEN EIGHT MOTION CARRIES.WE ARE ADJOURNED FROM THIRD SPECIAL SESSION WE WILL NOW ALLOW THE CLERKS TO CHANGE AND RESUME INTO OUR EMERGENCY SESSION.
