4. The Legislature did consent to the Executive Reappointment of Louisa M. Wessling to serve as a Member of the Guam Ancestral Lands Commission.

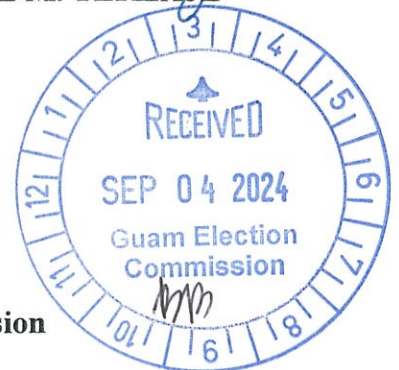
