1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds that the
3 University of Guam (UOG) is essential to developing, cultivating, and producing educated
4 citizens. UOG serves as a higher education institution with a purpose of serving the people
5 of Guam and the whole Micronesian region. During FY 2006 and 2008 the University
6 utilized funds from the UOG Higher Education Endowment Fund to make improvements
7 to the RFK Public Library. Additionally, UOG used requested funds to purchase library
8 equipment to modernize the necessary area for students, visitors, and faculty.

9 Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate funds from
10 the earnings of the University of Guam Higher Education Endowment Fund, as of
11 the end of fiscal year 2019, to the University of Guam.

12 **Section 2. Appropriation to the University of Guam.** The sum of up to
13 Four Hundred Thirty Three Thousand Dollars (\$433,000) is appropriated from the
14 UOG Higher Education Endowment Fund, as of the end of Fiscal Year 2019, to the
