BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. Hours of Sale: Off-Sale. §3417 of Article 4, Chapter 3, Title 11 of the Guam Code Annotated, is hereby amended, to read:

“§ 3417. Same: Off-Sale.

(a) Except as otherwise provided in subsection (b) of this section, an ~~An~~ off-sale licensee shall not sell alcoholic beverages between the hours of 12:00 a.m. and 2:00 p.m. ~~9:00 a.m.~~ of any day.

(b) An off-sale licensee shall not sell alcoholic beverages between the hours of 2:00 a.m. and 9:00 a.m. of any of the following:

(1) Saturdays and Sundays,

(2) holidays, as provided in 1 GCA §1000 (a) and (b), and

(3) any holidays declared by I Maga'håga or I Maga'låhen Guåhan as provided in 1 GCA §1000 (c).”

Section 2. Effective Date. This Act shall be effective on the first (1st) day or the first (1st) calendar month following the enactment of this Act.
