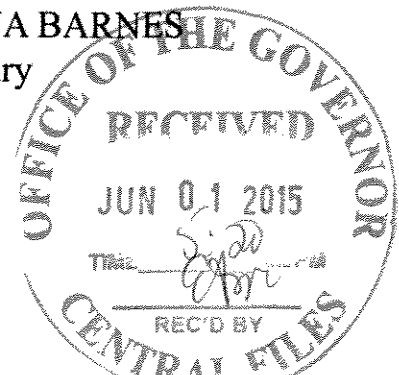


CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LAHEN GUÅHAN

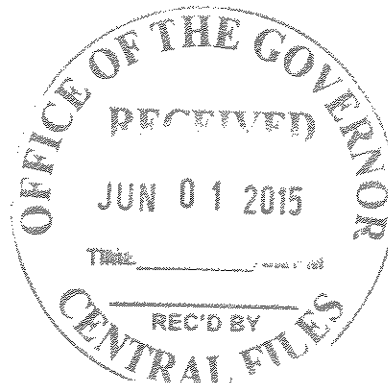

**AN ACT TO ADD A NEW § 3101.3 TO ARTICLE 1 OF
CHAPTER 3, TITLE 16, GUAM CODE ANNOTATED,
RELATIVE TO ENABLING THE REGISTRATION OF
ELIGIBLE VOTERS INCIDENT TO OBTAINING A
GUAM MOTOR VEHICLE DRIVER'S LICENSE OR A
GUAM IDENTIFICATION CARD, AND RENEWALS OF
SAME.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new § 3101.3 is hereby *added* to Article 1 of Chapter 3, Title
3 16, Guam Code Annotated, to read as follows:

1 **“§ 3101.3. Voter Registration Incident to Applications for**
2 **Driver’s Licenses and Identification Cards, and Renewals of Same.**

3 (a) Every person applying at the Department of Revenue and
4 Taxation for a Guam driver’s license or the renewal of said license, or
5 a Guam identification card or the renewal of said identification card,
6 and who meets all the eligibility requirements to register to vote
7 pursuant to Chapter 3, Title 3, Guam Code Annotated, *shall* be
8 afforded the opportunity to register to vote, or if previously registered,
9 to change their address for voting purposes, subject to the closing and
10 opening of registration pursuant to § 3104 of Chapter 3, Title 3, Guam
11 Code Annotated; and subject to the prohibition on the transfer of
12 registration between the primary and general election pursuant to §
13 3107 of Chapter 3, Title 3, Guam Code Annotated.

14 (b) The application to register to vote must be offered
15 simultaneously with the application for the Guam driver’s license, the
16 Guam identification card, or renewal of either or both. Department of
17 Revenue and Taxation employees must provide to applicants for
18 Guam driver’s licenses or Guam identification cards, or renewals of
19 either or both, the same level of assistance and instruction with respect
20 to the application to register to vote as is provided with respect to
21 applications for Guam driver’s licenses, Guam identification cards, or
22 renewals of either or both; *provided*, that separate signatures *shall* be
23 required on the application for a Guam driver’s license or Guam
24 identification card (or renewal of either or both), and the application
25 to register to vote. The applicant may decline to register to vote by
26 failing to sign the voter registration form. In order to protect the
27 privacy of those who do not wish to register to vote for any reason,

1 the failure of an applicant for a Guam driver's license or a Guam
2 identification card, or the renewal of either or both, to sign the voter
3 registration form may *not* be used for any purpose other than to
4 determine the person's voter registration status.

5 (c) (1) The voter registration application *shall* contain the
6 applicant's name, residence address, mailing address if different from
7 residence address, date of birth, and the applicant's signature and the
8 date of affixation of signature, and may include any other information,
9 certifications, and declarations, including those made under the
10 penalty of perjury, that may be required by the Guam Election
11 Commission in order to administer a single and unified system of
12 voter registration in accordance with applicable local and federal laws
13 which *shall* enable duly registered voters to vote in all elections in
14 their respective municipality, division or districts, including, elections
15 for federal officers. The voter registration application must also
16 include the statement that unlawful voter registration is a crime and
17 any person who willfully causes, procures or allows himself or herself
18 or any person to be registered as a voter, knowing himself or herself
19 or other person not to be entitled to registration, is guilty of a felony
20 of the third degree.

21 (2) It *shall* be the responsibility of the Department of
22 Revenue and Taxation to print and to have available at all times
23 a sufficient number of voter registration forms in order to carry
24 out the provisions of this Section.

25 (d) The completed voter registration application *shall* be
26 transmitted by the Department of Revenue and Taxation to the Guam
27 Election Commission *no later than* five (5) business days after the

1 date of acceptance by the Department of Revenue and Taxation.
2 Transmission may be made by electronic means as prescribed by the
3 Guam Election Commission, and in an electronic form compatible
4 with the voter registration system maintained by the Guam Election
5 Commission. For each registration electronically transmitted, a hard
6 copy will be provided to the Guam Election Commission.

7 (e) Any person who has fully and correctly completed an
8 application at the Department of Revenue and Taxation to register to
9 vote is presumed to be registered as of the date of the acceptance of
10 the registration by the Department of Revenue and Taxation, subject
11 to verification of the registration by the Executive Director of the
12 Guam Election Commission, as provided in § 3102 of Chapter 3, Title
13 3, Guam Code Annotated.

14 (f) Refusal by an applicant to register to vote *shall not* be a
15 basis for the denial of a Guam driver's license or a Guam
16 identification card, or the renewal thereof.

17 (g) The Guam Election Commission *shall* have the authority
18 to adopt regulations to implement and administer the provisions of
19 this Section, including all registrations taken at the Department of
20 Revenue and Taxation.”
