

AN ACT TO APPROPRIATE FUNDS FROM THE FISCAL YEAR 2014 HOTEL OCCUPANCY TAX (HOT) SURPLUS FUND FOR THE PAYMENT OF CAPITAL NEEDS OF THE GUAM MEMORIAL HOSPITAL AUTHORITY.

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds

3 that there exists Three Million Five Hundred Thousand Dollars (\$3,500,000) in the

4 Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund available for appropriation.

1 Section 2. Appropriation. Notwithstanding any provision of law, the 2 sum of One Million Six Hundred Thousand Dollars (\$1,600,000) is hereby 3 appropriated from the Fiscal Year 2014 Hotel Occupancy Tax Surplus Fund to the Guam Memorial Hospital Authority for the purchase of a Computerized Axial 4 5 Tomography (CAT) Scan machine and related supplies. Notwithstanding the 6 general provisions of § 30107.1, of Chapter 30, Title 11 GCA, this appropriation 7 shall continue to be available until expended and is not subject to transfer or use 8 for any other purpose.
