
**CERTIFICATION OF PASSAGE OF AN ACT TO I MAGA'LÁHEN GUÁHAN**

**AN ACT TO REZONE LOT NO. 3257-4-2 IN THE  
MUNICIPALITY OF *SINAJANA* FROM  
AGRICULTURAL ZONE (A) TO COMMERCIAL ZONE  
(C).**

1           **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2           **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds  
3 that Saied Safabakhsh, the property owner of Lot No. 3257-4-2 in the municipality  
4 of *Sinajana* which is currently designated as an Agricultural Zone (A), seeks to  
5 rezone the property to a Commercial Zone (C) for the purpose of expanding a

1 facility for medical services that was constructed on adjoining Lot No. 3257-4-R2,  
2 which is zoned as a Commercial Zone (C).

3 *I Liheslaturan Guåhan* further finds that because the lot is zoned as an  
4 Agricultural Zone (A), the owner is not allowed to use the property to its fullest  
5 potential. By rezoning the property, the owners will be able to increase the array  
6 of needed medical services that will benefit the community and the surrounding  
7 area.

8 Furthermore, *I Liheslaturan Guåhan* finds that Lot No. 3257-4-2 fronts  
9 Route 4, and is consistent with the commercial activity of the surrounding area  
10 which is compatible with the uses allowed in the proposed zone change proposed  
11 herein.

12 Therefore, it is the intent of *I Liheslaturan Guåhan* to rezone Lot No. 3257-  
13 4-2 in the municipality of *Sinajana* from Agricultural Zone (A) to Commercial  
14 Zone (C).

15 **Section 2. Lot Rezoning.** Notwithstanding any other provision of law,  
16 Lot No. 3257-4-2 in the municipality of *Sinajana* is hereby rezoned from  
17 Agricultural Zone (A) to Commercial Zone (C).
