AN ACT TO APPROPRIATE THREE HUNDRED THOUSAND DOLLARS (\$300,000) FROM THE GUAM PRESERVATION TRUST FUNDS AUTHORIZED IN SECTION 2 OF PUBLIC LAW 33-19 TO THE DEPARTMENT OF PUBLIC WORKS FOR THE REPAIR OF THE UMATAC BRIDGE TOWERS IN ANTICIPATION OF THE 12TH FESTIVAL OF PACIFIC ARTS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Appropriation. Notwithstanding any other provision of law,
- 3 the amount of up to Three Hundred Thousand Dollars (\$300,000) is hereby
- 4 appropriated from the Guam Preservation Trust funds authorized in Section 2 of

- 1 Public Law 33-19 to the Department of Public Works for the repair of the *Umatac*
- 2 Bridge Towers. This appropriation shall not lapse and shall remain available for
- 3 the purpose identified herein until fully expended.
- 4 Section 2. Reporting Requirement. No later than thirty (30) days
- 5 following the completion of repair work to the Umatac Bridge Towers, the
- 6 Director of the Department of Public Works shall submit a report to the Speaker of
- 7 I Liheslaturan Guåhan and to I Maga'låhen Guåhan detailing all expenditures
- 8 made pursuant to the requirements of this Act and of Public Law 33-19.
