AN ACT TO AMEND SECTION 1(X)(2)(B) OF CHAPTER V OF PUBLIC LAW 33-66, RELATIVE TO FUNDING THE OPERATIONAL START-UP COSTS OF THE GUAM MUSEUM.

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Section 1(x)(2)(B) of Chapter V of Public Law 33-66 is hereby
3 amended to read as follows:

4 "(B) The sum of Five Hundred Twenty-Nine Thousand Seven
5 Hundred Thirty Dollars (\$529,730) is appropriated from the Tourist
6 Attraction Fund to the Guam Museum Fund for the *sole* purpose of funding

Guam Museum operational start-up costs, pursuant to § 87136(h), Chapter 87,
 Title 5 GCA. Notwithstanding the general provisions of § 30107.1 of Chapter
 30, Title 11 GCA and this Act, this appropriation *shall* continue to be available
 until expended, and is *not* subject to transfer or use for any other purpose."
