AN ACT TO ADD A NEW SUBSECTION (5) TO SECTION 1(ee) OF CHAPTER V OF PUBLIC LAW 33-66, RELATIVE TO PROVIDING **SUPPLEMENTAL** FUNDING AND AUTHORIZATION TO THE GUAM ELECTION COMMISSION FOR ITS FY 2016 **OPERATIONS** AND FOR **PAYMENTS** ON **OBLIGATIONS INCURRED IN PRIOR YEARS.**

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. A new Subsection (5) is hereby *added* to Section 1(ee) of Chapter
- 3 V of Public Law 33-66 to read:

2016 Primary Election Funding. I Maga'låhen Guåhan shall 1 "(5) 2 identify and transfer the aggregate sum of Six Hundred Four Thousand Seven 3 Hundred Sixty-Nine Dollars (\$604,769) from the General Fund Executive 4 Branch appropriations contained in this Chapter, and in Parts II, III and IV of Chapter III of this Act, with the exception of Items (1) and (2) of this 5 Subsection (ee), to the Guam Election Commission no later than May 31, 6 2016. The Director of the Bureau of Budget and Management Research shall 7 notify the Speaker of I Liheslaturan Guåhan no later than five (5) working 8 9 days after such transfer is made."

Section 2. Authority to Make Payments on Obligations in Prior Years.
 The Guam Election Commission is hereby authorized to utilize unexpended funds
 to pay for obligations incurred in prior years.

13 Section 3. Effective Date. This Act *shall* become effective upon
14 enactment.

15 Section 4. Severability. If any provision of this Act or its application to 16 any person or circumstance is held invalid, the invalidity *shall not* affect other 17 provisions or applications of this Act that can be given effect without the invalid 18 provision or application and to this end the provisions of this Act are severable.
