

AN ACT TO AMEND SECTION 1 OF PUBLIC LAW 32-208, RELATIVE TO EXCLUDING SENATORS OF *I LIHESLATURAN GUÁHAN* FROM THE COMPETITIVE WAGE ACT OF 2014; AND TO ADD A NEW § 1106.1 TO CHAPTER 1, TITLE 2, GUAM CODE ANNOTATED, RELATIVE TO REDUCING THE COMPENSATION OF SENATORS OF *I LIHESLATURAN GUÁHAN*.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Section 1 of Public Law 32-208 is hereby *amended* to read:

3 “Section 1. Section 1 of Public Law 32-126 is hereby *repealed* and
4 *reenacted* to read:

5 **Section 1.** Notwithstanding any other provision of law, rule,
6 regulation, policy, or procedure, the salaries of *I Maga'låhen Guåhan*, *I*

1 *Segundu na Maga'låhen Guåhan*, and the Attorney General of Guam, shall
2 be set to the respective salary rates pursuant to the Competitive Wage Act of
3 2014, which was transmitted and received by *I Liheslaturan Guåhan* on
4 January 15, 2014. The appropriations from FY 2015 are hereby authorized
5 for the payment of salaries of the positions identified in this Section. The
6 salaries of the Public Auditor of Guam and staff of the Office of Public
7 Accountability shall be set pursuant to § 1907 of Chapter 19 of Title 1,
8 Guam Code Annotated. Nothing in this section shall repeal or negate the
9 provisions contained in Public Law 32-166.”

10 **Section 2.** A new § 1106.1 is *added* to Chapter 1, Title 2, Guam Code
11 Annotated, to read:

12 “§ 1106.1. **Senatorial Salaries.** Notwithstanding any other
13 provision of law, rule, regulation, policy, or procedure, compensation of
14 each member of *I Liheslaturan Guåhan* [the Guam Legislature] shall be paid
15 in twenty-six (26) equal installments at the rate per annum of Fifty-Five
16 Thousand Three Hundred Seven Dollars (\$55,307); the compensation of the
17 Speaker of *I Liheslaturan Guåhan* shall be paid in twenty six (26) equal
18 installments at the rate per annum of Sixty Thousand Eight Hundred Thirty-
19 Seven Dollars (\$60,837). Such compensation shall be paid out of funds to be
20 appropriated to *I Liheslaturan Guåhan* [the Guam Legislature].”

21 **Section 3. Effective Date.** The provisions of this Act shall become
22 effective upon enactment.

23 **Section 4. Severability.** If any provision of this Act or its application to
24 any person or circumstance is found to be invalid or contrary to law, such
25 invalidity shall not affect other provisions or applications of this Act which can be
26 given effect without the invalid provisions or application, and to this end the
27 provisions of this Act are severable.
