**AN ACT TO AMEND § 3219(c) OF ARTICLE 2,
CHAPTER 3 OF TITLE 16, GUAM CODE ANNOTATED,
RELATIVE TO THE NOTICE REQUIREMENT FOR
THE SALE OF TIRES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that Public Law 32-214 updated the standards for the sale of tires. In order to
4 further clarify the notice requirements for the statutorily mandated standards, *I*
5 *Liheslatura* finds that the notice language should be revised accordingly to reflect
6 the changes in the standards approved by Public Law 32-214.

1 **Section 2.** § 3219(c) of Article 2, Chapter 3 of Title 16, Guam Code
2 Annotated, is *amended* to read:

3 “(c) Each retailer, wholesaler and distributor of tires on Guam *shall*,
4 at the place of sale, post in a conspicuous location, in letters at least two (2)
5 inches tall, a statement that indicates the dangers of aged tires. The statement
6 *shall* be printed as follows:

7 “WARNING – AGED TIRES CAN FAIL IN USE, CAUSING LOSS
8 OF VEHICLE CONTROL, AND PERSONAL INJURY. TIRES
9 DETERIORATE WITH AGE, EVEN WITH LITTLE OR NO USE.
10 TIRES OLDER THAN TEN 10 YEARS MAY NOT BE SOLD OR
11 MOUNTED FOR USE ON VEHICLES OPERATED ON THE
12 HIGHWAYS AND ROADWAYS OF GUAM.”
