**AN ACT TO APPROPRIATE UP TO FIFTY THOUSAND DOLLARS (\$50,000) FROM THE GENERAL FUND FOR THE REPAIR OF THE INARAJAN SPORTS FACILITIES' ELECTRICAL SYSTEMS AND LIGHT FIXTURES AT THE MALOJLOJ MULTIPURPOSE COURT, THE INARAJAN VOLLEYBALL COURT, AND THE INARAJAN BASKETBALL COURT FOR FISCAL YEAR 2010.**

1           **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2           **Section 1. Legislative Findings and Intent.** On February 26, 2009 the  
3 Municipal Planning Council adopted a resolution requesting *I Liheslatura* to appropriate  
4 monies and to identify a viable funding source for the purpose of repairing the electrical  
5 systems and light fixtures at the Malojloj multipurpose court, the Inarajan volleyball  
6 court, and the Inarajan basketball court. Because of age, constant use, environmental  
7 effects, normal wear and tear and other reasons, the sport facilities located in the  
8 municipality of Inarajan became unusable during the night time hours. The electrical  
9 panels, switches, and controls render the facilities hazardous and unsafe for children who  
10 use the facilities. The lighting problems seriously impact the youths, community teams,  
11 users, and other organizations that now cannot use the facilities during the night. *I*  
12 *Liheslatura* finds that the Mayor's office has received complaints from community  
13 members expressing disappointment at the conditions of the facilities. *I Liheslatura* also  
14 finds that the Inarajan Mayor's office does not have the adequate funding to pay for the

1 needed repair. With the recent successful bond financing of the Government of Guam,  
2 the taxes withheld from the COLA payments resulted in new revenues which are not  
3 committed for any program yet. The bonds and the revenue of taxes infused into the  
4 economy provide additional funding currently not reflected in the FY 2010 budget  
5 projection.

6 Therefore it is the intent of *I Liheslatura* to provide the necessary funding for the  
7 repair of the Inarajan sports facilities' electrical systems and light fixtures at the Malojloj  
8 multipurpose court, the Inarajan volleyball court, and the Inarajan basketball court.

9 **Section 2. Appropriation.** The sum of up to Fifty Thousand Dollars (\$50,000)  
10 is hereby appropriated from the General Fund to the office of the Mayor of Inarajan for  
11 the sole purpose of repair of the Inarajan sports facilities' electrical systems and light  
12 fixtures at the Malojloj multipurpose court, the Inarajan volleyball court, and the Inarajan  
13 basketball court in Fiscal Year 2010. Such appropriation shall not lapse and shall remain  
14 available pursuant to this act until fully expended.
