**Relative to recognizing and commending Master Sergeant Irene M. Fejeran on her promotion, and congratulating her on being the first female enlisted soldier in the Guam National Guard to be promoted to Sergeant Major.**

1        **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2        *MINA'TRENTA NA LIHESLATURAN GUÅHAN:*  
3        **WHEREAS,** MSG Irene M. Fejeran is the daughter of the late Ignacio  
4        and Hisae Mitsui Fejeran from the village of Dededo, and the proud mother of  
5        Tavis, Remy and Steven and grandmother to Sopheary, Ayden, Kohana,  
6        Skyler and Aoki; and

1           **WHEREAS**, MSG Fejeran enlisted in the United States Army in May,  
2 1980, as an Administrative Specialist, undergoing eight (8) weeks of Basic  
3 Combat Training at Fort Dix, New Jersey, and eight (8) weeks of Advance  
4 Initial Training at Fort Jackson, South Carolina; and

5           **WHEREAS**, MSG Fejeran received her first active duty assignment with  
6 the 56<sup>th</sup> Field Artillery Brigade, as the Brigade Assignment Clerk under the 21<sup>st</sup>  
7 Replacement Detachment, Rhein-Main Air Base, Frankfurt Germany; and

8           **WHEREAS**, MSG Fejeran enlisted in the Guam Army National Guard in  
9 December 1983, and was later selected and placed on AGR Status in  
10 December 1984; and

11           **WHEREAS**, MSG Fejeran has had multiple assignments to include:  
12           Operations NCO – GUARNG Element, J3  
13           Unit First Sergeant – GUARNG Element  
14           SGM Personnel Division, J1; and

15           **WHEREAS**, MSG Fejeran has undergone numerous military training  
16 and education at the University of Vicennes, the Guam Community College  
17 and the Army Correspondence Course Program; and

18           **WHEREAS**, MSG Fejeran has been selected to attend the United States  
19 Army Sergeant Majors Academy Class 36, DL Phase I, to begin on August 2,  
20 2009; and

21           **WHEREAS**, MSG Fejeran has received many awards, decorations and  
22 citations to include:

1           The Meritorious Service Medal – 1<sup>st</sup> OLC  
2           The Army Commendation Medal – 2<sup>nd</sup> OLC  
3           The Army Achievement Medal – 3<sup>rd</sup> OLC; and

4           **WHEREAS**, MSG Fejeran is also the first female in the Guam Army  
5 National Guard to be promoted to Sergeant Major; now, therefore, be it

6           **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na*  
7 *Lihselaturan Guåhan* does hereby, on behalf of *I Lihselaturan Guåhan* and the  
8 people of Guam, recognize, commend and congratulate Master Sergeant Irene
