**Relative to *amending* Section 6.04.04.02 and Section 6.04.04.03
of *I Mina'Trenta Na Liheslaturan Guåhan Otden Areklamento*
(Thirtieth Guam Legislature Standing Rules).**

1 **BE IT RESOLVED BY I MINA'TRENTA NA LIHESLATURAN**
2 **GUÅHAN:**

3 **WHEREAS,** the Committee on Economic Development, the
4 Judiciary, and Health has oversight of the Guam Economic Development
5 and Commerce Authority, which is the government agency responsible for
6 the issuance, selling, and disposition of bonds. However, *I Mina'Trenta Na*

1 *Liheslaturan Guåhan Otden Areklamento* (Thirtieth Guam Legislature
2 Standing Rules) dictates that bills of bonds of any nature *shall* be referred to
3 a joint committee composed of the Committee on Appropriations and the
4 Committee on Economic Development. It is the intent of *I Mina'Trenta Na*
5 *Liheslaturan Guåhan*, however, to clarify the appropriate referral, and
6 therefore, to *amend* the Standing Rules to reflect such clarity; and

7 **WHEREAS**, Section 6.04.04.02, titled "Appropriations," is *amended* to
8 read as follows:

9 **"Section 6.04.04.02. Appropriations.** Substantive bills which
10 contain appropriations *or* authorizations for appropriations *shall* be
11 referred to the Committee on Appropriations. The annual budget bill
12 for the government and supplements to the annual budget bill *shall*
13 be referred to the Committee on Appropriations. Any bills on bonds
14 of any nature *shall* be referred to the Committee on Economic
15 Development, the Judiciary, and Health; provided, that bills on
16 bonds whose payment source is the General Fund *shall* be referred
17 sequentially, first to the Committee on Economic Development, the
18 Judiciary, and Health and next to the Committee on Appropriations.
19 Each year, the Chairperson *shall* designate one (1) appropriations bill
20 as the annual budget bill and may designate one (1) bill as the
21 supplemental annual budget bill. The annual budget bill *shall* be
22 done annually, and *shall* contain the budget for one (1) fiscal year
23 only. Unrelated appropriations *shall not* be considered germane,
24 *except* that the annual budget bill and one (1) annual supplement to
25 the annual budget bill may contain unrelated appropriations.

1 Administrative and miscellaneous provisions directly relating to the
2 budget and contained in the annual budget bill for the operation of
3 the government of Guam *or* to the one (1) supplement to the annual
4 budget bill, *shall* be considered germane"; and

5 **WHEREAS**, the Committee on Economic Development, the
6 Judiciary, and Health has oversight of the Judiciary, which is the
7 government agency responsible for managing the capital improvement
8 projects for the Judicial Branch and the Judicial Building Fund. However, *I*
9 *Mina'Trenta Na Liheslaturan Guåhan Otden Areklamento* (Thirtieth Guam
10 Legislature Standing Rules) dictates that any bills appropriating *solely* for
11 the Judicial Branch, inclusive of capital improvements, *or* from the Judicial
12 Building Fund *shall* be referred to a joint committee composed of the
13 Committee on Appropriations and the Committee on Economic
14 Development, the Judiciary, and Health. It is the intent of *I Mina'Trenta Na*
15 *Liheslaturan Guåhan*, however, to clarify the appropriate referral, and
16 therefore, to *amend* the Standing Rules to reflect such clarity; and


17 **WHEREAS**, Section 6.04.04.03, titled "Legislative Appropriations;
18 Other Branches," is *amended* to read as follows:

19 **"Section 6.04.04.03. Legislative Appropriations; Other**
20 **Branches.** Bills relating to appropriations *solely* for *I Liheslaturan*
21 *Guåhan shall* be referred exclusively to the Committee on Rules. Any
22 bills appropriating *solely* for the Judicial Branch, inclusive of capital
23 improvements, *or* from the Judicial Building Fund *shall* be referred to
24 the Committee on Economic Development, the Judiciary, and
25 Health"; now, therefore, be it


1 **RESOLVED**, that *I Mina'Trenta Na Liheslaturan Guåhan* does hereby,
2 on behalf of the people of Guam, adopt the aforementioned changes to *I*
3 *Mina'Trenta Na Liheslaturan Guåhan Otden Areklamento* (Thirtieth Guam
4 Legislature Standing Rules); and be it further

5 **RESOLVED**, that the Speaker certify, and the Secretary of the
6 Legislature attest to, the adoption hereof, and that copies of the same be
7 thereafter transmitted to the Chairperson of the Committee on Rules; and
8 to all the Members of *I Mina'Trenta Na Liheslaturan Guåhan*.
