1 BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I*
2 *MINA'TRENTA NA LIHESLATURAN GUÅHAN*:

3 **WHEREAS**, the Miss Earth Beauty Pageant, an annual international beauty
4 pageant promoting environmental awareness, has been held in the Philippines since it
5 was first established in 2001; and

1 **WHEREAS**, Guam will gain international recognition and establish goodwill
2 through its media exposure for holding the island’s first local Miss Earth Beauty
3 Pageant and sponsor the winner of the Miss Earth Beauty Pageant; and

4 **WHEREAS**, in terms of the national level competitions participating in the
5 world finals, the Miss Earth Beauty Pageant is one of the three (3) largest beauty
6 pageants in the world, along with the Miss Universe and Miss World contests; and

7 **WHEREAS**, the focus and determination to empower local youth and adults to
8 take on environmental issues and projects on Guam, was created by the Miss Earth
9 Guam Organization; and

10 **WHEREAS**, the Miss Earth Guam Organization has developed into a program
11 whose aspiration is to encourage Beauties for a Cause, a cadre of young leaders, and
12 ambassadors whose mission is to encourage not only our local community, but the
13 communities of the world through promoting awareness on the importance of
14 preservation, protection, and care for our environment; and

15 **WHEREAS**, the Miss Earth Guam victor will actively support environmental
16 organizations, corporations, and companies in a continuous effort to promote earth-
17 friendly products and practices; and

18 **WHEREAS**, many active involvements and promotions include continuous
19 participations in monthly recycling programs, the use of environmentally-friendly and
20 energy efficient light bulbs and appliances, islandwide tree planting projects,
21 community and beach cleaning, and restoration efforts, and the promotion and
22 nurturing of the Love of My Planet Tour, an educational drive focused at educating
23 young children on how they and their families can protect and save our environment;

25 **WHEREAS**, the Miss Earth Guam Organization, along with the national
26 licensed franchise for the Miss Earth Pageant, strive to set an optimistic model for our

1 national delegates, business partners and sponsors by highlighting the incredible
2 impact, even to the smallest organizations, they can create by simply applying
3 environmentally sound practices in their everyday business; and

4 **WHEREAS**, the Corporate, Community and Media Partners are the core of the
5 Miss Earth Guam Organization, and the Miss Earth Guam endeavors for the support
6 of these three (3) valuable sectors in our society to generate a powerful statement for
7 a sustainable future; and

8 **WHEREAS**, our island's involvement in this endeavor reinforces our binds to
9 our community to further illustrate the responsibility we each have to do our part to
10 protect this beautiful island we call home; now, therefore, be it

11 **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na Liheslaturan*
12 *Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people of Guam,
13 commend and congratulate the Guam Committee of the Miss Earth Beauty pageant,
14 under the direction of Frank B. Santos, Mark Enriquez and Adrian Diaz, for their
15 efforts to promote Guam in the international arena, and also for its efforts to protect
16 our environment, promote conservation measures and support the community's effort
17 to Keep Guam Clean; and be it further

- 2 Honorable Felix P. Camacho, *I Maga'lahaen Guåhan*.


