**Relative to commending Sergeant Joseph S. Carbullido
of the Guam Police Department for his notable act of
bravery in saving a person's life on May 24, 2009.**

1 **BE IT RESOLVED BY I MINA'TRENTA NA LIHESLATURAN**
2 **GUÅHAN:**

3 **WHEREAS,** Sergeant Joseph S. Carbullido was born in 1961 in Guam to
4 †Francisco Muña Carbullido and †Julianna Santiago Carbullido of *Agat*; and

5 **WHEREAS,** Sergeant Joseph S. Carbullido is married to Jennifer
6 Jerusalem, and together they have four (4) wonderful children: Collin
7 Carbullido, Joleen Carbullido, John Palanca, and Katrina Palanca, and they
8 reside in *Dededo*; and

9 **WHEREAS,** Sergeant Joseph S. Carbullido joined the Guam Police
10 Department in December 1988, he earned his rank of Police Sergeant in 2004,
11 and he has proudly served in the police force for more than twenty-one (21)
12 years; and

13 **WHEREAS,** Sergeant Joseph S. Carbullido has received numerous
14 awards, certificates, and commendations for his outstanding performance,
15 including several Guam Police Distinguished Service Medals, the Employee of
16 the Year for Public Safety, and the Supervisor of the Year for Public Safety;
17 and

18 **WHEREAS,** Sergeant Joseph S. Carbullido is a graduate of the
19 University of Guam, earning a Bachelor of Science degree in Criminal Justice
20 and Public Administration in 2006, and a Master's degree in Public
21 Administration and Supervision in 2008; and

1 **WHEREAS**, on the night of May 24, 2009, tragedy fell upon Guam's
2 roads, affecting several families, as Sergeant Joseph S. Carbullido, while off
3 duty, witnessed a two (2) car collision at the Route 16 Overpass; and

4 **WHEREAS**, upon witnessing this collision, Sergeant Joseph S.
5 Carbullido immediately stopped his vehicle, ran to one (1) of the vehicles that
6 was now on fire and discovered an unconscious male; and

7 **WHEREAS**, by instinct and being conditioned throughout his career as
8 a police officer, Sergeant Joseph S. Carbullido pulled the person out of the
9 inferno, without regard of his own safety to save the life of a fellow citizen;
10 now, therefore, be it

11 **RESOLVED**, that *I Mina'Trenta Na Liheslaturan Guåhan* does hereby, on
12 behalf of the people of Guam, commend and honor Police Sergeant Joseph S.
13 Carbullido for his notable act of bravery in saving a person's life on the night
14 of May 24, 2009; and be it further

15 **RESOLVED**, that the Speaker certify, and the Legislative Secretary
16 attest to, the adoption hereof, and that copies of the same be thereafter
17 transmitted to Sergeant Joseph S. Carbullido; to his wife Jennifer Jerusalem; to
18 Police Chief Paul Suba; and to the Honorable Felix P. Camacho, *I Maga'lahren*
19 *Guåhan*.
