13 from the government of Guam, culminating thirty-one (31) years of exemplary
14 service and personal dedication to securing the health and well-being of our
15 island citizens; and

17 recognized by former Senator Doris Flores Brooks in the 1990 Group
18 Performance Award for the Maternal and Child Health (MCH) Program, with

2 duty for her work in the First Aid Station, providing care to rescuers at the

7 Congressman Robert T. Underwood, Ph. D.; now, therefore, be it


8 **RESOLVED**, that *I Mina’Trenta Na Liheslaturan Guåhan* does hereby, on
