
1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2    ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS**, the Committee on Ethics and Standards was appointed on  
4    August 20.2009, and requires and allocation of funds by the Committee on  
5    Rules in order to exercise the powers and perform the duties granted to it,  
6    including organizing its staff and hiring of such secretarial, professional and  
7    stenographic help as necessary, pursuant to Sections 18.02 and 18.03 of the  
8    Standing Rules; now, therefore, be it

9           **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na*  
10   *Lihsaturan Guåhan* does hereby, on behalf of *I Lihsaturan Guåhan* and the  
11   people of Guam, allocate Fifteen thousand Dollars (\$15,000) to the Committee  
12   on Ethics and Standards as its start-up budget pending the submission of an  
13   additional formal budget request by the Committee; and be it further

14          **RESOLVED**, that the Speaker and the Chairperson of the Committee on  
15   Rules certify, and the Legislative Secretary attest to, the adoption hereof, and  
16   that copies of the same be thereafter transmitted to Senator Judtith T.  
17   Guthertz, Chairperson of the Committee of Ethics and Standards of *I*  
18   *Mina'Trenta Na Lihsaturan Guåhan*; and to the Honorable Felix P. Camacho, *I*  
19   *Maga'lahaen Guåhan*.


