1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**

10 Medal at the 2009 New York Festivals for the documentary about his life; and

12 women in the Philippines, including President Gloria Arroyo; and

13           **WHEREAS**, this highly-decorated man also has local roots, living on  
14 Guam for a short time until he was thirteen (13); and


15           **WHEREAS**, Mr. Sotto has graciously accepted an invitation to return to

18 Guam Chapter; and


19           **WHEREAS**, this is a rare opportunity for the local community to be
