**Relative to recognizing, commending, and joining with community partners who are taking action to celebrate this year's "Earth Week", from April 16 to April 24, 2010, and the Fortieth (40<sup>th</sup>) Anniversary of "National Earth Day" on April 22, 2010.**

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**  
2    ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3           **WHEREAS**, forty (40) years after the first “Earth Day”, as climate  
4 change has become the greatest challenge of our time, and as our planet finds  
5 itself in greater environmental peril than ever, the people of Earth have  
6 concurrently reached a moment of unprecedented opportunity, in which the  
7 goal of building a healthy, prosperous, clean energy-driven economy for our  
8 future has become attainable; and

9           **WHEREAS**, “Earth Day 2010” can be an important turning point to  
10 advance climate policy, energy efficiency, renewable energy and green jobs,  
11 while the Earth Day Network is galvanizing millions to make personal  
12 commitments to sustainability; and

13           **WHEREAS**, Guam joins the more than one billion people in one  
14 hundred ninety (190) countries taking action during “Earth Day” and “Earth  
15 Week 2010” taking advantage of a pivotal opportunity for individuals,  
16 corporations and governments to join together and create a global green  
17 economy; and

18           **WHEREAS**, Guam’s celebration of “Earth Week 2010” began on Friday,  
19 April 16, 2010, with a Proclamation signing declaring April 16 to April 24,  
20 2010 as “Earth Week,” with this year’s theme of “I Am a Green Generation”;  
21 and

1       **WHEREAS**, the Guam Environmental Protection Agency, in  
2 coordination with Guam’s public and private schools, raised awareness of the  
3 issue of climate change by hosting environmental education events including:

- 4       • A 3-D Artwork and Photography Contest, which encouraged  
5 students to create artwork made primarily of reused, reusable, recycled  
6 or recyclable materials; the students’ work was displayed at the *Agana*  
7 Shopping Center on Friday, April 16, 2010; and
- 8       • A Recycled Dress Fashion Show, which encouraged participants to  
9 create attire using entirely reused materials, and also took place on  
10 Friday, April 16, 2010; and

11       **WHEREAS**, the Guam Hotel and Restaurant Association joined in the  
12 celebration of “Earth Week 2010” with a beach clean-up on Sunday, April 18,  
13 2010; and

14       **WHEREAS**, the Guam Energy Office, in conjunction with Guam EPA,  
15 celebrated “National Earth Day 2010” with a morning wave on April 22, 2010,  
16 at the DPW intersection on Marine Corps Drive; and

17       **WHEREAS**, this year’s “Earth Week” commemoration will culminate  
18 with the *Guåhan* Earth Festival, a family-oriented event to spread  
19 environmental awareness, to be held on Saturday, April 24, 2010, at *Ypao*  
20 Beach Park from 9:00 a.m. to 3:00 p.m.; now, therefore, be it

21       **RESOLVED**, that the Committee on Rules of *I Mina’Trenta Na*  
22 *Liheslaturan Guåhan*, on behalf of *I Liheslaturan Guåhan* and the people of

1 Guam, does hereby recognize, commend, and join with community partners  
2 who are taking action to celebrate this year's "Earth Week", from April 16 to  
3 April 24, 2010, including the Fortieth (40<sup>th</sup>) Anniversary of "National Earth  
4 Day" on April 22, 2010; and be it further


5       **RESOLVED**, that the Speaker and the Chairperson of the Committee on
