13 drive: the largest event promoting literacy on Guam; and


14 **WHEREAS,** the collaboration between IRA and its "Partners in Literacy"

20 for more than a decade; and be it further


21 **RESOLVED,** that the Speaker certify, and the Legislative Secretary
