3 **WHEREAS**, on Guam, the private sector not only ensures the
4 economic success of the island, but also contributes to the overall island
5 community; and

6 **WHEREAS**, every year, the Guam Chamber of Commerce honors
7 leaders and companies in the business community for their dedication to
8 Guam and her people, by inducting them into the Guam Business Hall of
9 Fame; and

10 **WHEREAS**, this year's Guam Business Hall of Fame 2010 Business
11 Laureate is Foremost Foods, Inc.; and

12 **WHEREAS**, Foremost Foods began as International Dairy Supply
13 Co., originally a milk and ice cream producer for military units on Guam
14 that commenced business with the Guam community in 1950, at the
15 request of Governor Carlton Skinner; and

16 **WHEREAS**, sixty (60) years later, Foremost Foods is one (1) of
17 Guam's few local producers, offering a large variety of dairy, juice, soda,
18 and water products, and operating in a state of the art plant, with products
19 distributed through its own transport network to outlets around the island;

21 **WHEREAS**, with its success, the company continues to foster a
22 positive relationship with its employees, clients, suppliers, and the
23 community at large; and

1 **WHEREAS**, Foremost Foods frequently contributes to hundreds of
2 organizations and events each year, and the company and its staff support
3 numerous civic organizations, such as the American Cancer Society's Relay
4 for Life; the *i recycle* Program; various events of the Guam Chapter of the
5 American Red Cross; events in the villages; events at schools and
6 educational facilities; programs to counteract such social ills as violence
7 against women; and a multitude of sporting events; now, therefore, it be

9 on behalf of the people of Guam, congratulate Foremost Foods, Inc. on
