18 their efforts to shape Guam's future; now, therefore, be it


19           **RESOLVED,** that the Committee on Rules of *I Mina'Trenta Na*

22 Graduation; and does further commend Guam High School's Administration,


1 Faculty, Staff, Parents and Students on their efforts to educate Guam's next
