5 Awards”, named in honor of Shieh Su Ying, grandmother of Dr. Thomas
6 Shieh; and

8 physician and philanthropist, Dr. Thomas Shieh, to nurture children into
9 healthy adulthood, challenging them with high expectations, encouraging
10 abstinence from drugs, alcohol, and tobacco, and rewarding academic and

12 **WHEREAS**, nominees are chosen from Guam’s high schools who have
13 exhibited exceptional academic and athletic ability, and who concurrently
14 participate in a varsity sport while maintaining a grade point average of no
15 less than 3.4; and

16 **WHEREAS**, every year since 2002, Dr. Shieh has presented the awardees
17 and nominees with a monetary prize and gifts at a memorable ceremony
18 commemorating each student’s accomplishment; and

19 **WHEREAS**, recipients of the “Shieh Su Ying Male and Female Scholar-
20 Athlete of the Year Award” have excelled in their university studies, have
21 represented Guam well while off-island, and have been role models worthy of
22 emulation; and

1 **WHEREAS**, the Shieh Su Ying Male and Female Scholar-Athlete of the
2 Year Award Program challenges Guam’s youth to high achievement, allows
3 them to experience the rewards of success, and fosters within our community
4 the awareness that high achievement will be rewarded; and

5 **WHEREAS**, it is just such recognition and promotion that can broaden
6 the self-perception of a community, inspiring independent, determined youth
7 to excel in academics and sports, and to whom we confidently entrust the
8 future of our island; and
