WHEREAS, Ms. Misalucha's illustrious music career includes numerous awards; performances in Canada, Hong Kong, the United States, Singapore, Japan, and the Middle East; audiences with the King of Malaysia, the Sultan of Brunei and the Presidents of Singapore and e Philippines; and

WHEREAS, In 2004, Ms. Misalucha relocated to the United States, after being granted a visa as an "Alien of Extraordinary Ability;" and

WHEREAS, Ms. Misalucha regularly uses her talent to raise funds for church-related and humanitarian organizations; and

WHEREAS, the latest concert Ms. Misalucha will perform on our island aims to support spouses of deployed servicemembers on Valentine's Day; now therefore, be it
