


1 **BE IT RESOLVED BY *I MINA'TRENTA NA LIHESLATURAN GUÅHAN*:**

2 **WHEREAS**, the Federation of Asian and Pacific People on Guam has
3 been in existence for the past 15 years; and

4 **WHEREAS**, the original name of the organization was the Federation of
5 Asian People on Guam. Now it is the Federation of Asian and Pacific People on
6 Guam, adding the peoples of Palau and the Federated States of Micronesia to the
7 original Indian, Chinese, Korean, Vietnamese and Filipino people organizations
8 on Guam; and

9 **WHEREAS**, with the cooperation of Mr. Vashi Hemlani, Ms. Kim
10 Bottcher has successfully made her struggle to helping the Asahi and Peleliu
11 Club (Palau) in pushing for the approval of their land lease; and

12 **WHEREAS**, Ms. Kim Bottcher is a person of dignity, honor and
13 responsibility; and a School Teacher by profession for quite a number of years
14 with efficient service record; and

1 **WHEREAS**, due to Ms. Bottcher’s efforts to increase membership with
2 the Federation, the organization is now at seven and still recruitment is going on;
3 and

4 **WHEREAS**, with Ms. Tessie Marcos as the incoming President of
5 the Federation of Asian and Pacific People on Guam, we are confident that there
6 is a continued success of the organization; and now therefore, be it
