



ORGANIZATION" FOR PROVIDING THE
EFFECTIVE LEADERSHIP, DEDICATION, AND
COMMITMENT TO OUR ISLAND'S YOUTHS.

1 BE IT RESOLVED BY THE EXECUTIVE COMMITTEE OF I
2 MINA'TRENTA NA LIHESLATURAN GUÅHAN:

3 WHEREAS, the Youth for Youth Organization began nineteen years ago in
4 May of 1988, continues to strive through effective leadership, enthusiasm, dedication
5 and commitment of its members and our island's youth every year. Y4Y is a team of
6 individuals working together by sharing ideas and responsibilities in order to
7 accomplish their programs and community prevention activities; and

8 WHEREAS, Y4Y, a non-profit community-based substance abuse prevention
9 program for youths between the ages of eleven to seventeen, and the organizations
10 main focus is to train our youths as drug prevention practitioners. This year will be
11 the 19th Annual Y4Y Conference with its theme "Think"; and

12 WHEREAS, throughout the last nineteen years, Y4Y's annual conference
13 services approximately five hundred middle and high school student teams and are
14 recruited primarily as participants for this particular conference; Local middle and
15 high school students undergo a year round prevention training and serve as members
16 of the Annual Youth Conference Planning Committee; and

17 WHEREAS, some of the programs the Youth for Youth Organization, has
18 implemented over the last 19 years include the Summer Swim and Water Safety
19 Program; the Annual National Red Ribbon Week, a grassroots Substance Abuse
20 Awareness effort; the Annual National Kick Butts Day, a day when thousands of

1 children stand up against tobacco addiction and the adults stand up for the children;
2 and be it further

3 **RESOLVED**, that *I Mina'Trenta Na Liheslaturan Guåhan* does hereby, on
4 behalf of the people of Guam, honor, commend and congratulate the "Youth for Youth
5 Organization" for their effectiveness in youth leadership, enthusiasm, dedication and
