1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA TRENTA NA***
2 ***LIHESLATURAN GUÅHAN*:**

3 **WHEREAS**, Paul Errol Angoco, II, resident of Agat, was born on December 30, 1983 to
4 Paul E. and Rita Marie Angoco; and

5 **WHEREAS**, Errol Angoco is an active member of the Guam Motorcycle and ATV
6 Corporation (GMAC), and at a relatively young age started competing in local Guam Motorcycle
7 and ATV Corporation (GMAC) races winning the 2004 GMAC Championships Series 65cc 1st
8 place, and

9 **WHEREAS**, Errol, with the support of his parents, Paul and Rita, moved up to a higher
10 class of bike, the 85cc, winning the 2005 GMAC Championships Series 85cc 2nd place; the
11 2006 GMAC Championships Series 3rd place overall; the 2006 Smokin' Wheels 85cc 1st place;
12 the 2007 Smokin' Wheels 85cc 1st place; the 2007 GMAC Championships Series 85cc 1st
13 place; the and 2008 GMAC Championship Series 125cc 1st place; and the 2008 Smokin' Wheels
14 125cc 1st place; and

15 **WHEREAS**, Errol, in his competitive participation in the motorcycle sport, raced in the
16 2004 Marianas Motocross Championships Saipan winning the 65cc 1st place; the 2005 Marianas
17 Motocross Championships Saipan 85cc 3rd place; he also raced in the international circuit,
18 placing 12th place in the 2005 44th Woodville Motocross Grand Prix, New Zealand 85cc as a

1 rookie; winning the 2006 Marianas Motocross Championships Saipan 85cc Expert 1st place; the
2 2008 SIC-MALAYSIAN Motocross Championships Sepang, Malaysia 125cc Novice 1st place;
3 and in other Guam fiesta motorcycle races, winning 1st place in the 65 cc and 85 cc respectively
4 from 2004 to 2007; and

5 **WHEREAS**, in 2003, GMAC was able to start participation in the UAM (Asian
6 Motorcycle Union) Motocross Championship Racing under the umbrella of NAMSSA
7 (Philippine Motorcycle Federation). Though international racing was held on Guam, GMAC
8 was not recognized as a FIM (Federation Internationale de Motorcyclisme, International
9 Motorcycle Federation) Member. GMAC riders raced their first UAM race in Macau in October
10 2003 and later on Guam in November of the same year in Guam's first UAM Asian Motocross
11 Championship; and

12 **WHEREAS**, Errol competed in the 2004 FIM/UAM Asian Motocross Championships
13 Guam Cup, winning the 65cc 1st place; and

14 **WHEREAS**, in 2005, GMAC wanted to host future international UAM racing as a FIM
15 National Motorcycle Federation, and GMAC Board Member Stanley Yasuhiro was sent to
16 Geneva, Switzerland to present our petition to join Federation Internationale de Motorcyclisme
17 (FIM), a world organization, at their annual General Membership meeting. After presenting
18 GMAC's petition and an introductory speech before the FIM President, Officials and National
19 Federation representatives, GMAC became a National Motorcycle Federation, and a FIM
20 member. In 2006, Greg Perez became Guam's first FIM Motocross Race Steward, a FIM
21 certified official who ensures FIM's stringent racing regulations at Guam races; and

22 **WHEREAS**, GMAC is also a member of the Asia Motorcycle Union (UAM) since 2005,
23 and UAM has been supporting and sponsoring the Asian Motocross Championship series for the
24 UAM member federation, and

25 **WHEREAS**; Errol raced and competed against the best Junior Riders among the twenty
26 (20) Federations member countries of UAM, competing in the 2005 FIM/UAM Asian Motocross
27 Championships 65cc and winning 1st place; the 2007 FIM/UAM Asian Motocross, Puerto
28 Princessa, Philippines 85cc winning 5th place; and winning the prestigious 1st place in the 85cc
29 at the 2008 FIM/UAM Asian Motocross, Puerto Princessa, Philippines; and he has been awarded

1 and recognized as the Number One Junior rider for the calendar year 2008 at the UAM Asian
2 Championship Series; and

3 **WHEREAS**, on February 28, 2009 at an official UAM dinner presentation at Puerto
4 Princessa, an official of GMAC accepted the Number One Junior Championship award on behalf
5 of Paul Errol (Errol) Angoco, II; and

6 **WHEREAS**, Errol aspires to continually grow and succeed in the sport of Motocross and
7 envisions himself as one day racing, and perhaps representing Guam as a professional racer
8 against top-seeded racers from the continental United States and around the world; now,
9 therefore, be it

10 **RESOLVED**, that the Committee on Rules of *I Mina Trenta Na Liheslaturan Guåhan*
11 does hereby, on behalf of *I Liheslaturan Guåhan* and of the people of Guam, recognize and
12 congratulate Paul Errol (Errol) Angoco for his dedication, success and participation in the contest
13 sanctioned by the Guam Motorcycle and ATV Corporation (GMAC) and does further
14 congratulate him on his winning the prestigious 1st place in the 85cc at the 2008 FIM/UAM
15 Asian Motocross, Puerto Princessa, Philippines; and be it further

16 **RESOLVED**, that the Speaker and the Chairman, Committee on Rules, certify, and the
17 Legislative Secretary attest to, the adoption hereof, and that copies of the same be thereafter
18 transmitted to Paul Errol (Errol) Angoco; to his parents, Paul and Rita; to the Guam Motorcycle
19 and ATV Corporation (GMAC); to Greg Perez, FIM Motocross Race Steward; to Stanley
20 Yasuhiro, GMAC Board Member; to Mr. Stephen Carapiet, President, FIM Asian Motocross and
21 Enduro Commission, Vice President of UAM Asian Motorcycle Union Motocross and President,
22 NAMSSA (Philippine Motorcycle Federation); to the FIM (Federation Internationale de
23 Motorcyclisme, International Motorcycle Federation); and to the Honorable Felix P. Camacho, *I*
24 *Maga'Lahen Guåhan*.
