3 **WHEREAS**, the Miss Earth Beauty Pageant, an annual international beauty
4 pageant promoting environmental awareness, has been held in the Philippines since
5 it was first established in 2001; and

6 **WHEREAS**, Guam will gain international recognition and establish
7 goodwill through its media exposure for holding the island's first local Miss Earth
8 Beauty Pageant and sponsor the winner of the Miss Earth Beauty Pageant; and

9 **WHEREAS**, in terms of the national level competitions participating in the
10 world finals, the Miss Earth Beauty Pageant is one of the three largest beauty
11 pageants in the world, along with the Miss Universe and Miss World contests; and

12 **WHEREAS**, the focus and determination to empower local youth and adults
13 to take on environmental issues and projects, on Guam, was created by the Miss
14 Earth Guam Organization; and

1 **WHEREAS**, the Miss Earth Guam Organization has developed into a
2 program whose aspiration is to encourage Beauties for a Cause, a cadre of young
3 leaders and ambassadors whose mission is to encourage not only our local
4 community but the communities of the world through promoting awareness on the
5 importance of preservation, protection, and care, for our environment; and

6 **WHEREAS**, the Miss Earth Guam victor will actively support
7 environmental organizations, corporations, and companies in a continuous effort to
8 promote earth friendly products and practices; and

9 **WHEREAS**, many active involvements and promotions include continuous
10 participations in monthly recycling programs, the use of environmentally friendly
11 and energy efficient light bulbs and appliances, island wide tree planting projects,
12 community and beach cleaning and restoration efforts and the promotion and
13 nurturing the Love of My Planet Tour, an educational drive focused at educating
14 young children on how they and their families can protect and save our
15 environment; and

17 licensed franchise for the Miss Earth Pageant, strive to set an optimistic model for
