**WHEREAS,** Attorney David Yokozeki was born on January 9, 1924 in Los Angeles, California and is married to the former Yoshiko Tamao of Tokyo, Japan. They currently reside in Jonestown, Tamuning and proud parents of four (4) children: Chris, Michael, Naomi and Miki;

**WHEREAS,** Attorney David Yokozeki moved to Guam in 1972 from Tokyo, Japan to assist Japanese companies during the growth of Guam during the 1970's and 1980's with specific focus in the Tumon area; and

**WHEREAS,** Attorney Yokozeki was the only Japanese speaking attorney in Guam in the early 1970's and worked closely with local Guam business people -- †Edward M. Calvo and †Governor Ricardo J. Bordallo, proprietor of the Toyota dealership at the time -- assisting them in their dealings with Japanese businesses; and

**WHEREAS**, Attorney Yokozeki was very generous with his time providing legal services to Island residents less fortunate, his daughter Miki remembers him accepting small gifts such as a blanket instead of payment. Friends and family fondly remember Attorney Yokozeki being always very humble and never offensive. He assisted insurance and car rental businesses with employee issues including †Mr. Earl Kloppenburg's family-owned business; and

**WHEREAS**, Attorney Yokozeki worked on notable projects on the Island including the Oka Towers in Tamuning, the Daisei-Telefofo Golf Course known and frequented by avid golf enthusiasts as the Country Club of the Pacific, and Tokyu Development in Dededo; and

**WHEREAS**, Attorney David Yokozeki is a well known and a respected attorney in Guam and has been an avid fisherman, golfer, and bridge player. His professional work ethics with his colleagues and friends have always been above and beyond and, and, now therefore, be it
