4 *Filipino*, is Guam's only Filipino language talk show that airs from 8 to 10 a.m.
5 every Saturday on KTKB 101.9 FM; and

6 **WHEREAS, *Damdaming Pinoy*** is hosted on a voluntary basis by a
7 dedicated group of professionals, namely, Roy Adonay, Sam Mabini, Ph.D. and
8 Beth Cena, and, assisted by different local Filipino personalities and other ethnic
9 community leaders and constituents; and

10 **WHEREAS, *Damdaming Pinoy*** focuses on everyday issues that Filipinos
11 residing on Guam and the CNMI are concerned with, like health care, education,
12 labor laws, immigration and upcoming events within the Filipino community; and

13 **WHEREAS, *Damdaming Pinoy*** disseminates public service information,
14 celebrates local Filipino accomplishments, as well as perpetuates a better
15 understanding of Filipino culture through discussions on Philippine history,
16 languages, values and customs; and

1 **WHEREAS, *Damdaming Pinoy*** educates young Filipinos through different
2 Filipino cultural tidbits such as *bugtong* (riddle), *salawikain* (proverb) and *kataga*
3 (idiomatic expression) as well as Philippine history trivia; and

4 **WHEREAS, *Damdaming Pinoy*** also serves as a valuable channel for
5 outreach and assistance for Filipinos and other listeners of the program; now
6 therefore be it

7 **RESOLVED**, that *I Mina'Trenta Na Liheslaturan Guahan* does hereby, on
8 behalf of the people of Guam commend and congratulate ***Damdaming Pinoy*** on
9 their continued success and their second anniversary; and be it further
