18           **WHEREAS**, as the inaugural guest lecturer, Dr. Carlos will deliver a lecture entitled "US  
19 Strategic Policy in the Asia Pacific: A Philippine Perspective" at the University of Guam; and

2 entitled “Challenges of Democratic Deficits in Republic of the Philippines,” providing insight to the
