Relative to approving the expenditure of One Thousand Three Dollars and Eight Cents (\$1,003.08) from the Central Operations Budget of *I Mina' Trenta na Liheslaturan Guåhan*, the Thirtieth Guam Legislature, for three accounting personnel to attend a Payroll Seminar in Saipan.

1           **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I MINA'***  
2           ***TRENTA NA LIHESLATURAN GUAHAN:***

3           **WHEREAS**, the U.S. Internal Revenue Service and the CNMI  
4 Division of Revenue and Taxation will be co-sponsoring a "Payroll  
5 Seminar" on Tuesday, March 2, 2010 at the Multi-Purpose Center in  
6 Susupe, Saipan; and

7           **WHEREAS**, this seminar is a supplement to the annual seminar  
8 conducted by the Division of Revenue and Taxation in December, and  
9 covers other payroll related issues outside of the filing of the annual  
10 reconciliation of wages and salary and the Form W2-CM"; and

11           **WHEREAS**, because of scheduling constraints the training could not  
12 be held in Guam; now, therefore, be it

1           **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na*  
2 *Liheslaturan Guåhan*, on behalf of *I Liheslaturan Guåhan* and the people of  
3 Guam, does hereby approve the expenditure of One Thousand Three  
4 Dollars and Eight Cents (\$1,003.08) – broken down as follows: Seven  
5 Hundred Twenty-One Dollars and Eight Cents (\$721.08) for three airline  
6 tickets, Forty-Five Dollars (\$45.00) for car rental, and Two Hundred Thirty-  
7 Seven Dollars (\$237.00) for a per diem rate of Seventy-Nine Dollars (\$79.00)  
8 per person – for three accounting personnel to attend this seminar; and be  
9 it further
