1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I MINA'**
2 **TRENTA NA LIHESLATURAN GUÅHAN:**

3 **WHEREAS**, in a small island like Guam, community service
4 organizations have a real chance to make a difference; and

5 **WHEREAS**, community groups can also foster goodwill throughout the
6 island in a way that is not felt anywhere else but Guam; and

7 **WHEREAS**, the Laguna Association of Guam was formed by local
8 families hailing from Laguna, a province of the Philippines, namely, Afuang,
9 Agbada/Cahinhinan, Baldemor, Baet/Gagaring, San Agustin, Milano and
10 Guevara who gathered on January 17, 2000 and conducted its first
11 organizational meeting; and

1 **WHEREAS**, during the month of March of 2010, Laguna Association of
2 Guam will celebrate its 10th Anniversary of promoting brotherhood and
3 friendship to all Filipinos and Fil-Chamorros regardless of province-birth; and

4 **WHEREAS**, throughout its 10 year history, Laguna Association of
5 Guam has excelled in its mission of service to the community through
6 charitable contributions to non-profit organizations such as Guam Lytico &
7 Bodig Association, American Red Cross, American Cancer Society, Alee
8 Shelter, Catholic Social Service, Make-A-Wish Foundation; and

9 **WHEREAS**, taking pride in being a part of the island community,
10 Laguna Association of Guam constructed and dedicated a picnic shelter
11 complete with bar-b-que pit and shower facility at the Paseo de Susana Park
12 in Hagåtña to the Department of Parks and Recreation; and

13 **WHEREAS**, in October 2008, Laguna Association of Guam, proud of its
14 rich cultural heritage, erected and installed on the grounds of the official
15 residence of the Consul General of the Philippines in Tamuning a bust statue
16 of Dr. José Rizal, the Philippine's national hero and whose birthplace was
17 Calamba, Laguna; now, therefore, be it
